**ORDINANCE NO. 2012-(“A” for introduction)**

**AN ORDINANCE AMENDING CHAPTER §228-50 SCHEDULE XVI: PARKING PROHIBITED CERTAIN HOURS” OF THE CODE OF THE CITY OF AMSTERDAM**

**BY: ALDERMAN LEGGIERO**

**WHEREAS**, Bridge Street now has ample available off street public and private parking, and

**WHEREAS**, Bridge Street is too narrow to accommodate on street parking, and

**WHEREAS**, the Chief of Police requests that parking on Bridge Street be prohibited at all times,

The City of Amsterdam, in Common Council convened, does hereby,

**ORDAIN AND ENACT** as follows:

Chapter §228-50 Schedule XVI “Parking Prohibited Certain Hours” of the code of the City of Amsterdam is hereby amended as indicated below: (items struck through are to be deleted)
