**RESOLUTION AUTHORIZING INCREASE IN USER FEES ABOVE 3% TAX CAP –
WATER, SEWER AND SANITATION**

WHEREAS, a 3% tax cap for user fees is in effect under City Charter section 89,

WHEREAS, the proposed 2013-2014 proposed budget calls for an increase of over 3% in certain user fees for water, sewer and sanitation, and it is deemed necessary and in the interest of the municipality to increase these rates by an amount greater than 3%,

RESOLVED, the Common Council hereby approves an increase over 3% for the Sewer charges per 100 cubic feet, the water user fees, and the sanitation user fees for the 2013-2014 budget.
