**AN ORDINANCE AMENDING CHAPTER 206 OF THE CODE OF THE CITY OF AMSTERDAM**

**BY: ALDERMAN ISABEL**

WHEREAS, it is necessary to revise the city code to amend Chapter 206 of the code of the City of Amsterdam,

The City of Amsterdam, in Common Council convened, does hereby,

**ORDAIN AND ENACT** as follows:

Chapters§206 "Snow and Ice Removal" of the code of the City of Amsterdam are hereby amended as indicated below: (underlined text is added and struck through text is to be deleted)

§206-24. Sand and Ashes

It is further ordained that where the snow and ice are so frozen or congealed that they cannot be removed without injury to the sidewalk as above provided, the owner, occupant or person in charge of said lands and premises shall, within 12 hours after said freezing and congealing, strew, cause to be strewn and keep strewn the snow and ice on said sidewalk with sand or ~~ashes~~ other suitable abrasive material so as to make and keep the same safe for public traffic thereon

§206-25. Penalties for Offenses

Any violation of the terms and provisions of this article shall be punishable by a fine of ~~not less than \$2 and not more than \$5~~ not more than \$100 ~~or by imprisonment of not less than two days or more than five days, or by both such fine and imprisonment.~~
