This resolution states that businesses are being negatively impacted because of the partial closure of Main Street on Saturday mornings for the Farmers' Market. This is an anecdotal accounting that has no empirical evidence provided.

The resolution requests that the Police Chief not allow the closure of Main Street. Direction of staff is an executive function. I will not direct the Chief to disallow this partial closure. The practice of closing off a street to entice new pedestrian traffic is successful in Troy and Schenectady, and elsewhere around the state. The Farmers' Market is welcome to continue until its planned conclusion in October.

This resolution attempts to modify the recently approved operating budget without a recommendation by the mayor as required by Charter section 122. This section reads:

The Common Council, on recommendation of the Mayor, may authorize the Controller to transfer part or all of any unencumbered appropriation balance to another appropriation budget line; the transfer may be between or within any department or agency provided that no funds may be transferred in violation of any restrictions on use contained in this charter or any other applicable law.

As I have not recommended this modification, a resolution approving a modification is not effective to modify a duly adopted budget without my recommendation. I point this out because an override of this veto will not cause this transfer to comply with the City Charter.

**MEMORANDUM OF AGREEMENT**

**July 9, 2015**

WHEREAS, the United Public Service Employees Union (hereinafter the "UPSEU") and the City of Amsterdam (hereinafter the "City") are parties to a Collective Bargaining Agreement (hereinafter " the Agreement") between them which expired on June 30, 2014; and

WHEREAS, the parties have tentatively resolved the terms and conditions of a successor agreement, the contents of which are contained in this Memorandum of Agreement, which is subject to ratification by the membership of the UPSEU as well as the City Council;

NOW, THEREFORE, IT IS HEREBY AGREED by and between the parties that the following shall constitute the terms and conditions of a successor collective bargaining agreement to the 2011 - 2014 Agreement, subject to the ratification process referenced above.




