**AN ORDINANCE MODIFYING AMSTERDAM CITY CODE SECTION 228-47:
SCHEDULE XIII: PARKING PROHIBITED AT ALL TIMES**

BY: MAYOR CINQUANTI

Part 1: Legislative Intent: The Common Council having received a recommendation from Amsterdam Police Department Chief John Thomas to update the city code at Section 228-47 Schedule XIII: Parking Prohibited at all Times so as to remove No Parking at any time on the South side of Third Street , the intent of the instant ordinance is to modify Schedule XIII of Section 228-47 to allow for parking on the South side of Third Street

Part 2: Enactment –

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF AMSTERDAM that the following be added and or modified to XII o Section 228-47 as set forth below:

Remove:

Parking Prohibited at All Times: Third Street – South side

Part 3: Effectiveness: Following a public hearing and upon ratification by the Common Council, the instant Ordinance shall take effect pursuant to Section C-33 of the Charter.
